CALL TO ORDER:

The special board meeting was called to order at 12:00 o'clock, Noon, by President, Troy Guthrie. Members present at roll call: Troy Guthrie, Tracy Borden, and Kim White.

Kim White made a motion to adopt the written policies and procedures for post-issuance compliance, as presented. Tracy Borden seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Tracy Borden-yes; and Kim White-yes.

The board discussed the continuing disclosure obligation.

Kim White made a motion to receive bids for the \$350,000 General Obligation Building Bonds for this school district and award bonds to the lowest bidder. Tracy Borden seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Tracy Borden-yes; and Kim White-yes.

The lowest bidder was the Bank of Vici, in association with BOK Financial Securities, Inc., Oklahoma City, Oklahoma.

Kim White made a motion on a resolution providing for the issuance of General Obligation Building Bonds in the sum of \$350,000 by this school district authorized at an election called and held for such purpose; prescribing forms of bonds; providing for registration thereof; providing for levy of an annual tax for the payment of principal and interest on the same; and fixing other details of the issue. Tracy Borden seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Tracy Borden-yes; and Kim White-yes.

Kim White made a motion on a resolution designating the General Obligation bonds of 2018 as "Qualified Tax-Exempt Obligations" pursuant to Section 265 (b) (3) (B) of the Internal Revenue Code of 1986. Tracy Borden seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Tracy Borden-yes; and Kim White-yes.
