Troy Guthrie made a motion to adopt the written policies and procedures for post-issuance compliance. Justin Cole seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Justin Cole-yes; and Kim White-yes.

The board discussed the continuing disclosure obligation.

Troy Guthrie made a motion to receive bids for the \$170,000 General Obligation Building Bonds for this school district and award bonds to the lowest bidder. Justin Cole seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Justin Cole-yes; and Kim White-yes.

The lowest bidder was the Bank of Vici, in association with UMB Bank, N.A., Kansas City Missouri

Troy Guthrie made a motion on a resolution providing for the issuance of General Obligation Building Bonds in the sum of \$170,000 by this school district authorized at an election called and held for such purpose; prescribing forms of bonds; providing for registration thereof; providing for levy of an annual tax for the payment of principal and interest on the same; and fixing other details of the issue. Justin Cole seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Justin Cole-yes; and Kim White-yes.

Troy Guthrie made a motion on a resolution designating the General Obligation bonds of 2016 as "Qualified Tax-Exempt Obligations" pursuant to Section 265 (b) (3) (B) of the Internal Revenue Code of 1986. Justin Cole seconded the motion. Motion carried 3/0. Vote: Troy Guthrie-yes; Justin Cole-yes; and Kim White-yes.
